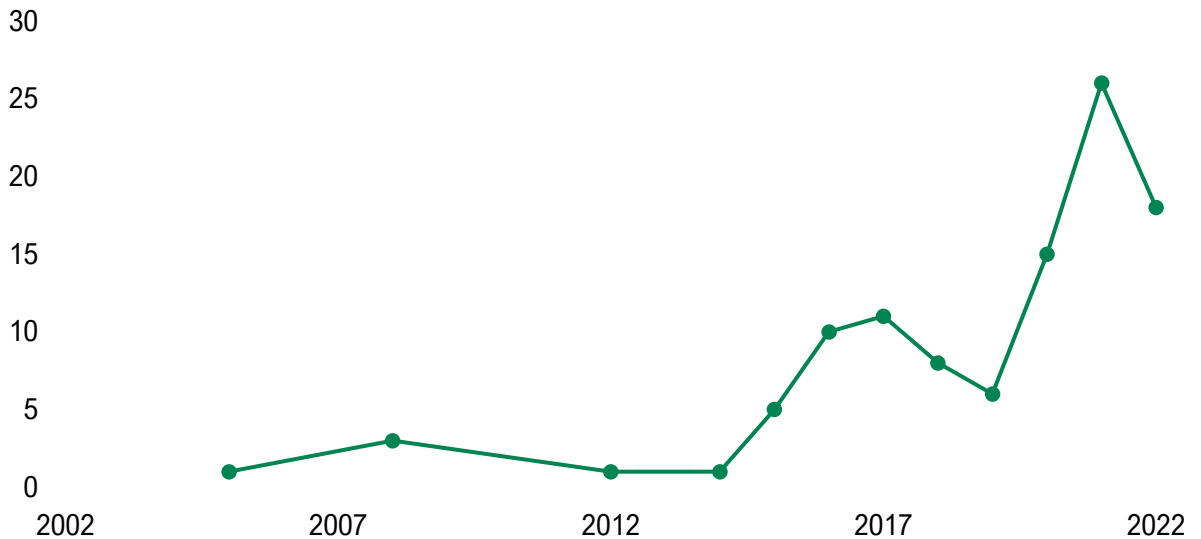


Summary of Countdown to 2030 Articles Related to Vaccines

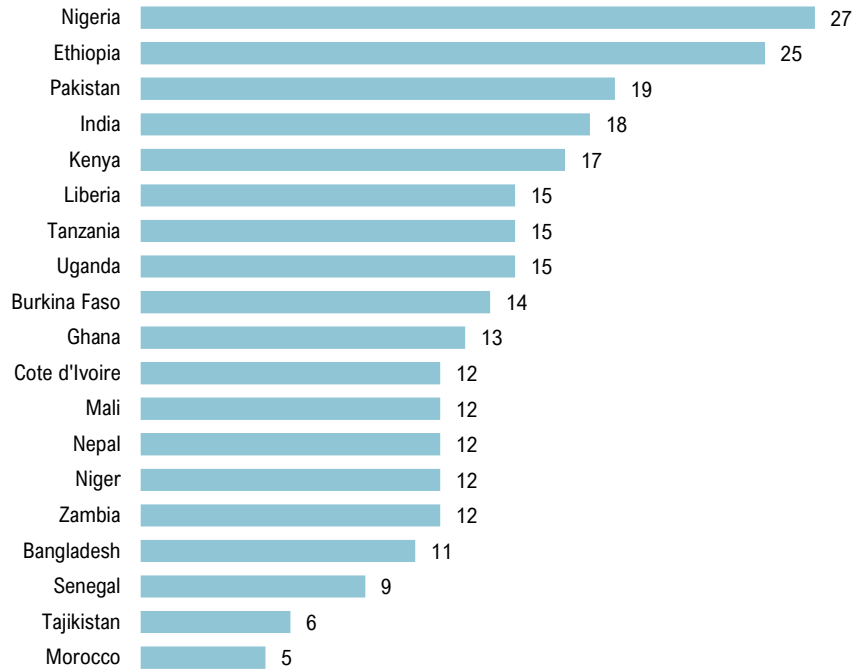
A total of 105 articles related to vaccines were published 2005-2022. The number of articles per year is shown below.

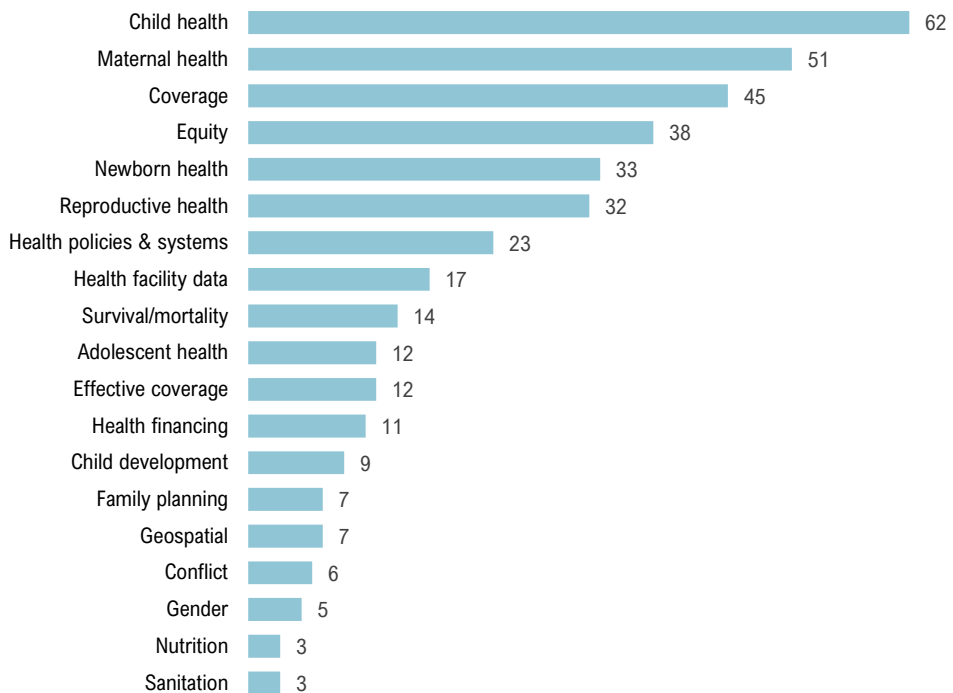
